There is a \$100.00 refundable security deposit for each instrument provided during the duration of this program. This deposit will be refunded upon return of the instrument within the condition referenced above.

Music Cost: Student must purchase music/CD required for lessons. Estimated cost not to exceed \$15.00.

Instruction Cost: The cost of instruction is \$20 per lesson. Families are asked to pay for what they can afford. Payment rare requested to be paid for the month in advance. (if needed weekly can be arranged in special cases)
